

PRODUCT DESCRIPTION

Emergency Eye/Facewash assemblies with ABS Yello-Bowl™ or no bowl models designed for wall mounting.



GENERAL INFORMATION

Following are requirements of ANSI Z358.1-1998 for Emergency Eyewash and Shower Equipment. A complete copy of this standard may be purchased from the International Safety Equipment Association.

1. The unit shall be positioned with the water nozzles are 83.8 cm (33 inches) to 114.3 cm (45 inches) from the floor and 15.3 cm (6 inches) minimum from the wall or nearest obstruction.
2. The unit shall deliver flushing fluid. The supply line shall provide an uninterrupted supply of water at 0.207 megapascal (30 pounds per square inch) of flow pressure. Where the possibility of freezing conditions exists, equipment shall be protected from freezing or freeze-protected equipment shall be installed. Units shall be installed in accordance with the manufacturer's instructions and acceptable plumbing practices.
3. When the unit is installed, the valve shall be operated to determine that both eyes will be washed simultaneously at a velocity low enough not to be injurious to the user.
4. Eyewash units shall be in accessible locations that require no more than 10 seconds travel time from the hazard.
5. Each unit location shall be identified with a highly visible sign. The area around or behind the eyewash, or both, shall be painted a bright color and shall be well lighted.

OPERATION & MAINTENANCE

1. Plumbed units shall be inspected weekly for proper pattern, flow volume and minimum requirements necessary to meet ANSI Z358.1-1998 standard.
2. A monthly record should be maintained to verify compliance with testing procedures.
3. Some chemical vapors or liquids may damage or soften plastic materials. Precaution should be taken to determine compatibility prior to use.

ASSEMBLY INSTRUCTIONS

NOTE: Use thread sealant on all joints except on ABS component eyewash or facewash heads.

1. Screw eyewash or facewash head assembly onto fountain, taking care not to cross thread. Hand tighten until snug. Back off.
DO NOT OVERTIGHTEN. CAUTION: DO NOT USE THREAD SEALANTS OF ANY TYPE.
2. Attach ball valve to 1/2" NPT potable water supply line.


ATTACHMENT TO WALL

Concrete Block: Use three (3) 1/4" toggle screws.

Concrete: Use three (3) 1/4" expansion anchors or equal

Stud: Cut piece of wood (1" x 8"). Wood should be long enough to bridge between studs. Fasten wood to existing studs, then attach bracket to wood using three (3) 1/4" lag screws.

CAUTION: CHECK FOR ADEQUATE WALL STRENGTH



TRAINING

All employees who might be exposed to chemical splash shall be instructed in the proper use of emergency eye/facewash units. Medical and industrial experiences have shown that initial first-aid treatment for chemical should be to wash the eyes and face for 15 minutes prior to medical treatment. It is important to hold the eyelids open and roll the eyes so water will flow on all surfaces and in the folds surrounding the eye.
