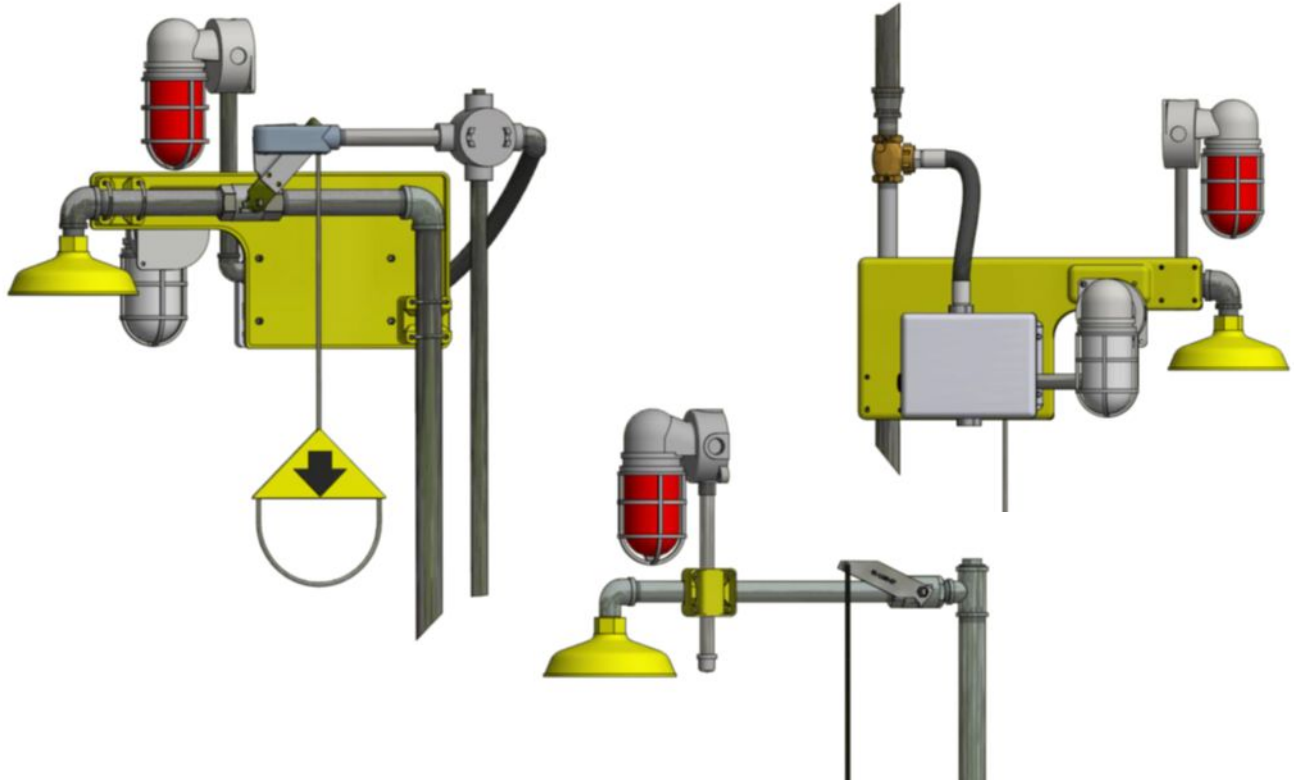


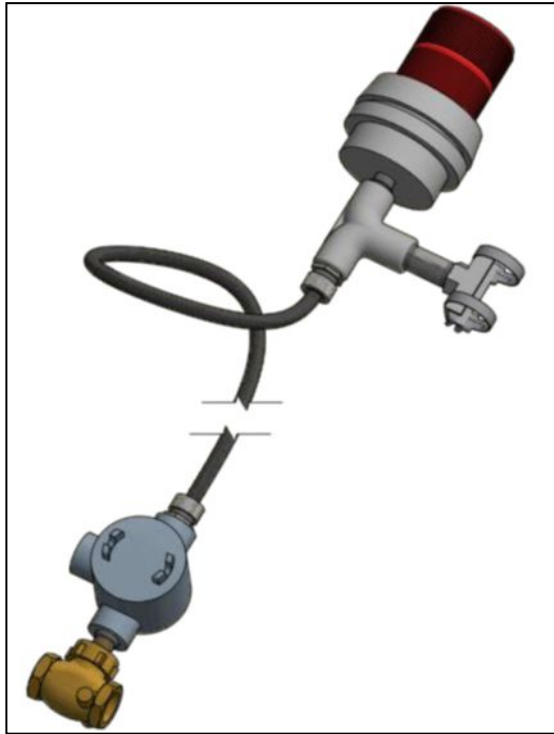
**AREA LIGHT AND/OR
ALARM KIT ASSEMBLIES****PRODUCT DESCRIPTION**

A variety of alarm systems including area locator lights, audio visual and remote alarms, to alert personnel when emergency showers or eyewash stations are in use.

**INSTALLATION INSTRUCTIONS**

- 1) Remove 1¼" plug from overhead pipe tee and insert into fountain section water inlet. (where applicable)
- 2) Refer to applicable junction box part number and schematic for your installation.
- 3) Install flow switch into overhead pipe section. Be sure to observe flow direction on housing. Be careful to keep sealing compound out of unit. (when applicable)
- 4) If your alarm kit assembly contains a yellow plastic junction box panel, secure to overhead and vertical piping with U-bolts provided. If not, secure conduit run to vertical piping with U-bolts provided.
- 5) At this time ensure that map-switch is aligned within a 1" horizontal of the bracket actuator. **Must be aligned correctly for proper alarm function.**
- 6) Make electrical connections per junction box drawing and schematic.
- 7) Perform operational test to ensure correct function of alarm kit.

Description: Alarm light and bell activated when shower/eyewash station is in use.

Activation Device: Flow switch includes relay rated @ 3 amps. 120 VAC, 60 Hz. Horizontal or vertical position acceptable. 1 1/4" NPT connection.

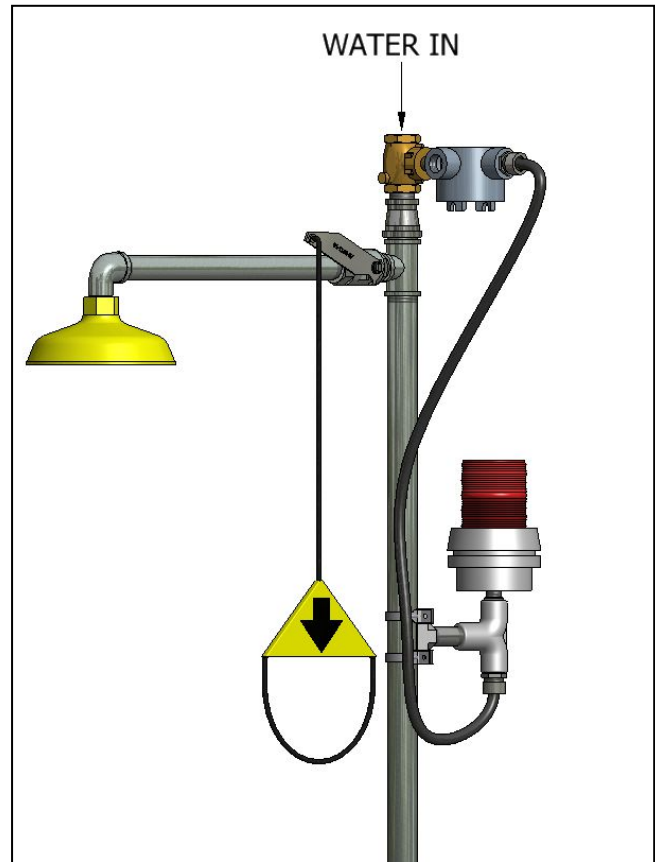
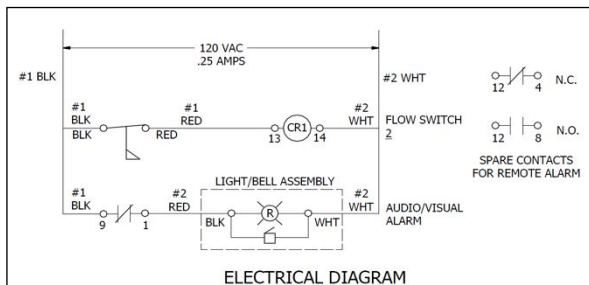
Light: Flashing red alarm light – 25 Watt lamp.

Audible Alarm: Audio signal rated 85 db @ 10ft.

Remote Alarm Contacts: Spare contacts (N.O. /N.C.) included.

Mounting Methods: Wall mount flange and pipe mount brackets included. Includes 7' cord between flow switch and light/bell.

Electrical Classification: Nema 3 rated – indoor and outdoor use. CSA listed components Mount vertically (light up) only.

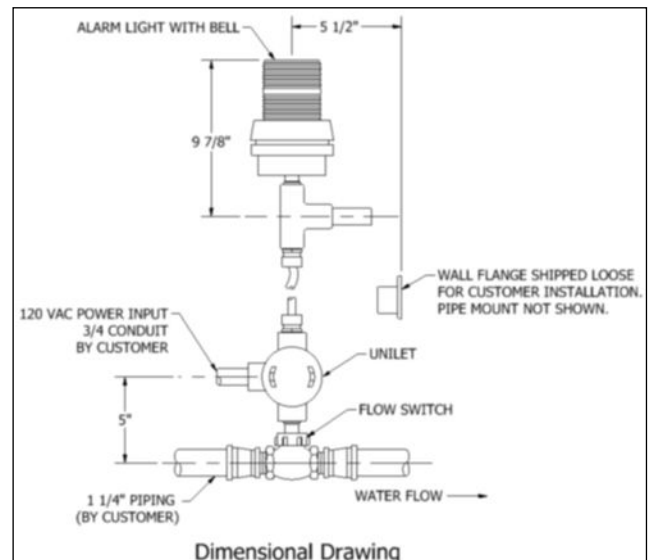


**ALARM MOUNTED ON SHOWER

Electrical Connection -

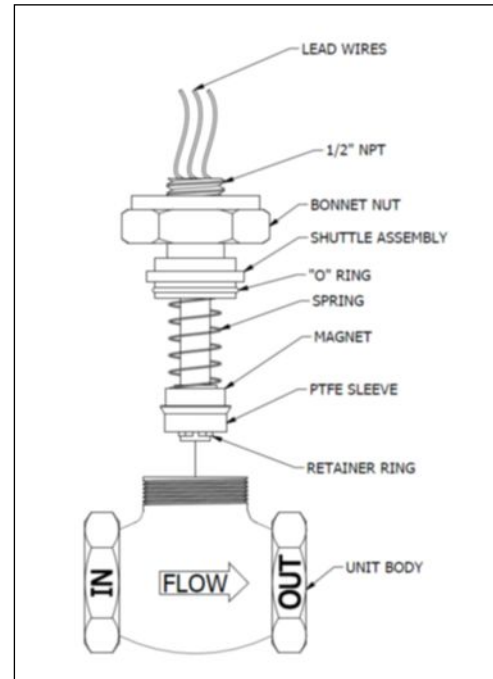
Lead wires and 1/2" NPT or junction box with 1/2" NPT.

Maintenance -

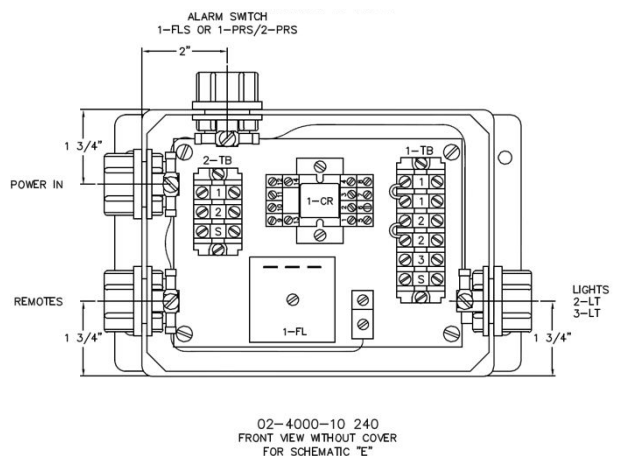
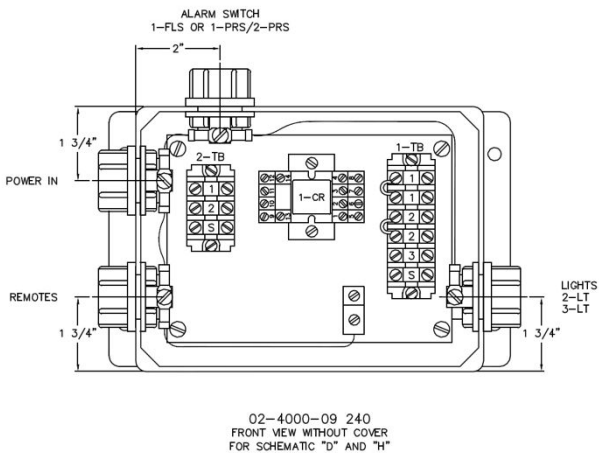
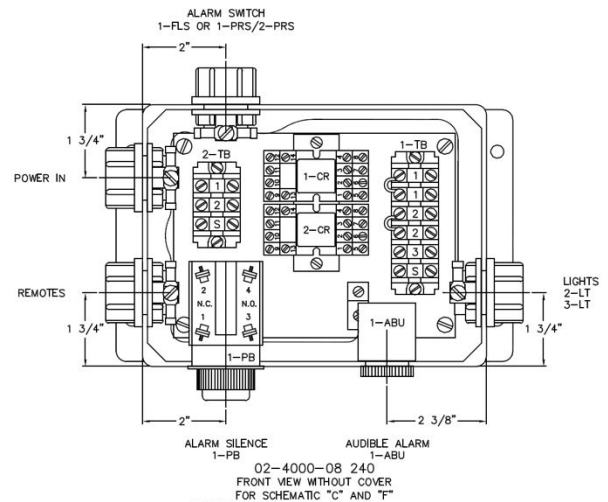
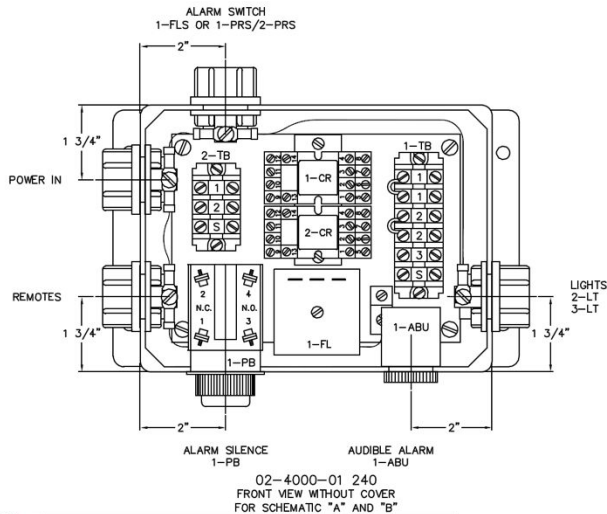
Occasional cleaning when excessive contamination is present in the liquid is the only maintenance normally required. With system shut-down and no liquid in piping, remove bonnet nut to disassemble unit for cleaning. It is not necessary to remove unit body from the system. Remove retainer ringer for complete shuttle disassembly.

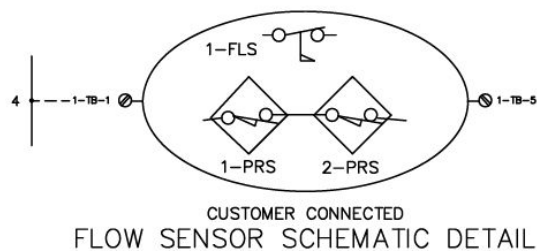
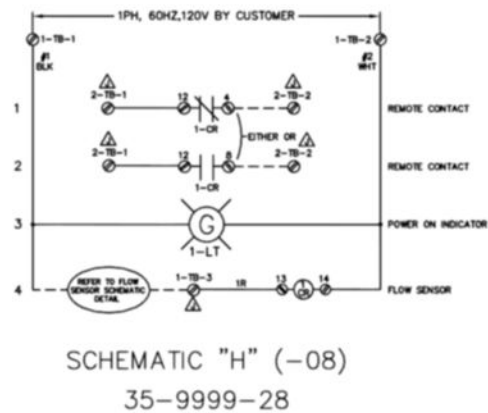
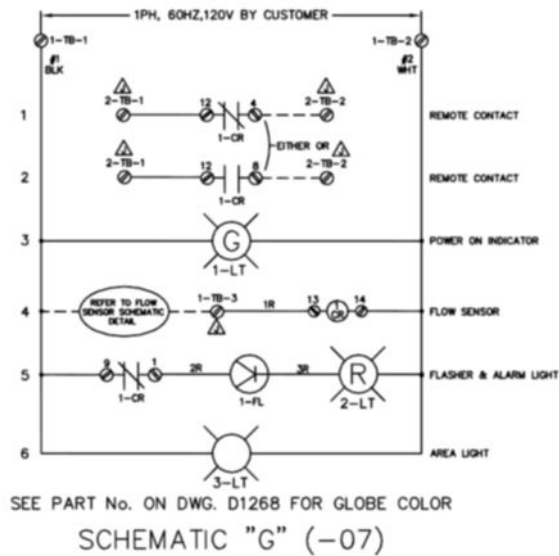
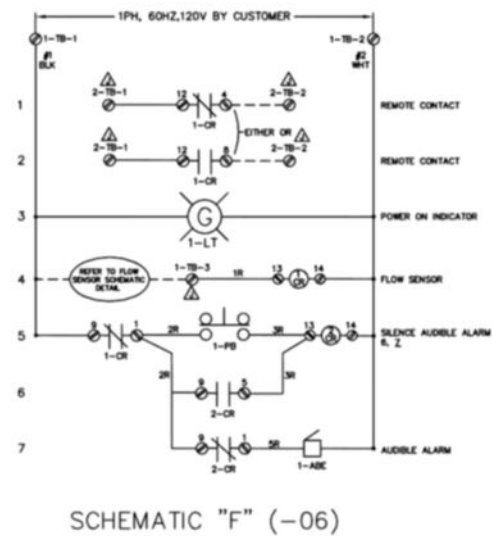
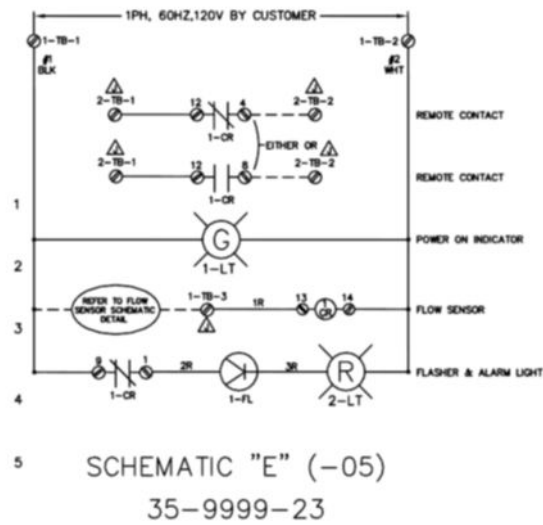
JUNCTION BOX LAYOUTS
