
1.0 ASSEMBLY AND INSTALLATION INSTRUCTIONS

Assembly

1. Clamp overhead bracket to horizontal piping of shower using mounting block and securing with U-bolts, hex nuts and washers (Fig 1).

NOTE: Do not tighten at this point of assembly.

2. Rough position mounting block to vertical shower piping using U-bolts, hex nuts and washers. **NOTE:** Do not tighten at this point of assembly.



- 3. Insert the two curtain rod halves into mounting block (Fig 2).
 - NOTE: Small radius end of curtain rod should be positioned at vertical piping of shower.
- 4. Assemble two connector halves to curtain rod with U-bolts, hex nuts, and washers. **NOTE:** Do not tighten at this point of assembly.



Assembly cont.

- Raise forward end of curtain /connector assembly to overhead bracket. Insert overhead bracket into connector half assembly (Fig 3).
- 6. Slide mounting blocks and overhead bracket to adjust height and level.
- 7. Tighten all hex nuts.




8. Attach shower curtain using included shower curtain hooks (Fig 4).

2.0 TRAINING
