

**PRODUCT DESCRIPTION**

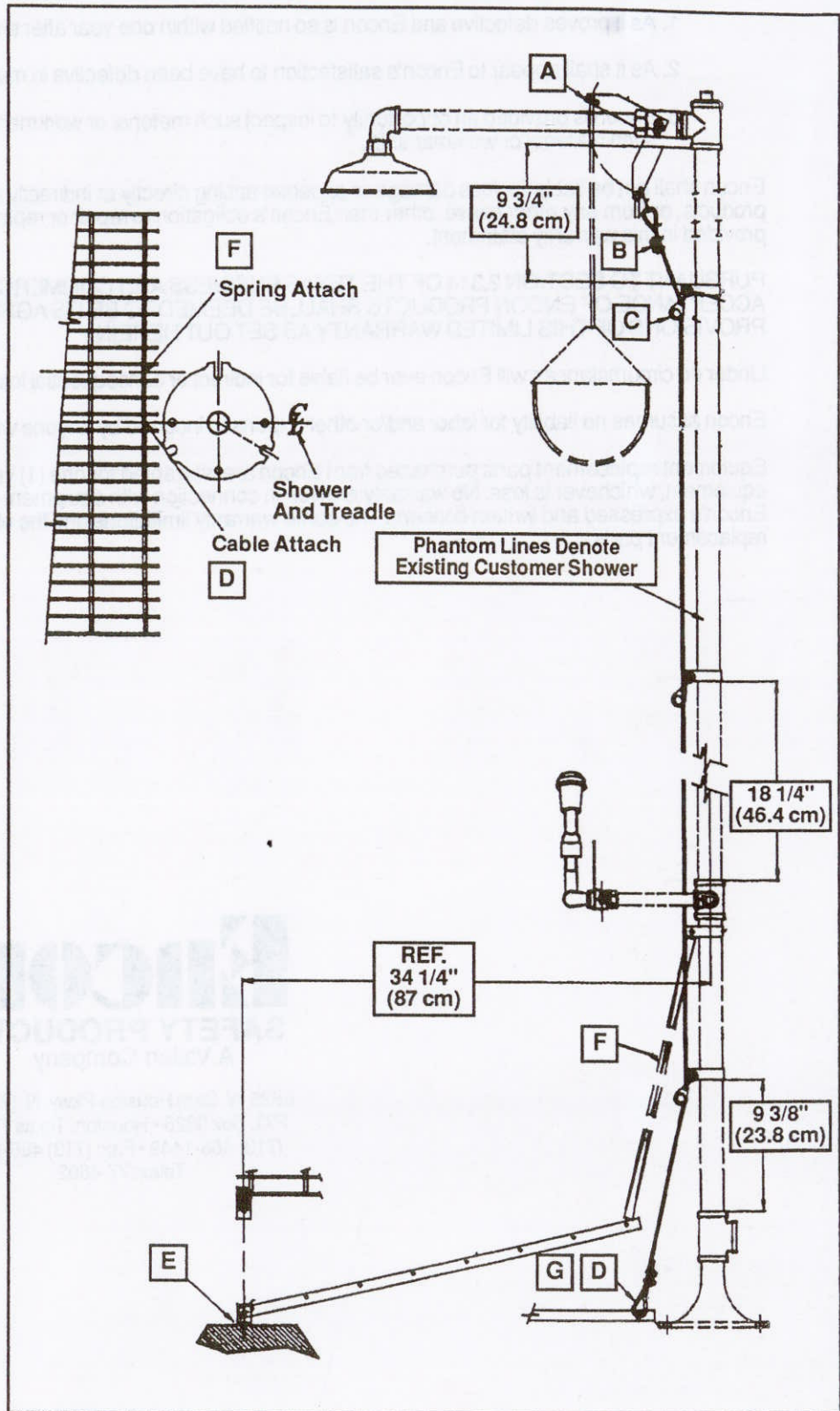
Walk On Treadle Sub-assembly for use on Combination Shower and No-Bowl Eyewashes.

**INSTALLATION/ASSEMBLY**

- A. Remove existing actuator arm from shower.
- B. Install actuator arm/cable assembly.
- C. Position clamp/pulley assemblies and secure.
- D. Assemble thimble eye and cable to cross bar of treadle, using (2) wire rope clips (finger tight only)
- E. Position treadle assembly and secure to floor with appropriate fasteners.
- F. Attach spring to shower and treadle.
- G. Adjust cable length as required and tighten wire rope clips.
