## EYE/FACEWASH STATIONS SUPPLY PIPE & WALL MOUNT MODELS



# **PRODUCT DESCRIPTION**

Emergency Eye and Facewash assemblies designed for supply pipe or wall mount in areas where people may come into contact with hazardous materials.




## **GENERAL INFORMATION**

Following are requirements of ANSI Z358.1 for Emergency Eyewash and Shower Equipment. A complete copy of this standard may be purchased from the International Safety Equipment Association.


- 1) Unit shall be installed in accordance with the manufacturer's instructions and acceptable plumbing practices.
- 2) The eye/facewash shall be positioned with the water nozzles between 83.8 cm (33 inches) and 114.3 cm (45 inches) from the floor and 15.3 cm (6 inches) minimum from the wall or nearest obstruction.
- 3) The unit shall be connected to a system capable of supplying adequate flushing fluid to meet the flow requirements of each component operating simultaneously. The supply line shall provide an uninterruptible supply of potable water at recommended minimum 0.207 megapascal (30 pounds per square inch) of flow pressure.
- 4) Where the possibility of freezing conditions exists, equipment shall be protected from freezing or freeze-protected equipment shall be installed.
- 5) When the unit is installed, it shall be tested in accordance with the following procedures:
  - a) With the unit correctly connected to the water source and the valve(s) closed, visually check the piping connection for leaks.
  - b) Open the valve to the full open position. The valve shall remain open without requiring further use of the operator's hands.
  - c) With the valve in the "full on" position, measure the flushing fluid flow pattern with the use of a test gauge to determine a suitable eyewash pattern as required by ANSI standards. Determine that both eyes can be irrigated simultaneously at a velocity low enough not to be injurious to the user.
- 6) Eyewash units shall be in accessible locations that require no more than 10 seconds travel time from the farthest hazard. NOTE: Test that all devices on combination units are capable of operating simultaneously to ANSI standard.
- 7) Each unit location shall be identified with a highly visible sign. The area around the unit shall be well lit.
- 8) Plumbed units shall be inspected annually for proper operation to ensure compliance to ANSI Z358.1 standard.

### ASSEMBLY INSTRUCTIONS

## CAUTION: CHECK FOR ADEQUATE WALL STRENGTH

### ATTACHMENT TO WALL (if applicable) NOTE: Mounting hardware is not included

Concrete Block: Concrete: Stud: Use three (3) 1/4" dia. toggle screws.

Use three (3) 1/4" dia. expansion anchors or equal

Cut piece of wood (1" x 8"). Wood should be long enough to bridge between wall studs. Fasten wood to existing studs, then attach bracket to wood using three (3)  $\frac{1}{4}$ " dia. lag screws.

NOTE: Use thread sealant on all joints except on ABS component eyewash or facewash heads.

- 1. Attach ball valve to 1/2" NPT potable water supply line using pipe wrench and appropriate pipe sealant.
- 2. Place push plate over stem of ball valve and attach with lock nut provided.
- 3. Screw eyewash or facewash head assembly onto fountain, taking care not to cross thread. Hand tightened until snug. Once snug, rotate back until eyewash heads are aligned with push plate (when in off position). CAUTION: Do not over tighten. Do not use pipe sealant or tape.
- 4. For proper operation of hinged lids, position hinges to the inside of the eyewash.
- 5. Test unit for leaks and for proper water flow pattern by activating valve to open position using push plate. (Recommended maximum dynamic water pressure 80 psi / minimum dynamic water pressure 30 psi)

Model 01052118 Wall Bracket Black aluminum wall bracket. Used with Yello-Bowl® models.

Model 01110042 Stainless steel wall bracket. Used with stainless steel bowl models.

# **OPERATION & MAINTENANCE**

- 1) Plumbed units shall be activated weekly to flush lines and verify proper flow pattern and volume.
- 2) Test records should be maintained verifying compliance with testing procedures.
- 3) Some chemical vapors or liquids may damage or soften plastic materials. Precaution should be taken to determine compatibility prior to installation.

## TRAINING

All employees who might be exposed to hazardous material shall be instructed in the location and proper use of emergency shower and eye/facewash units. Experiences have shown that initial first-aid treatment for irritates should be to wash the eyes and face for 15 minutes prior to medical treatment. It is important to hold the eyelids open and roll the eyes so water will flow on all surfaces and in the folds surrounding the eyes.
